



Offered in accordance with the Civil Registry of Laws 2002-2013, the Naturalisation of Investors by Exception Scheme is one of the fastest to lead to residence and citizenship in Europe.

Eligibility

- Possess a valid passport and a valid Schengen Visa
- Hold a clean criminal record from the country of origin and residence
- Hold a residence permit in Cyprus, before being granted citizenship
- Purchase and maintain a privately-owned residence in Cyprus of at least €500,000 plus applicable VAT
- Choose one of the prescribed investment options for €2 million and maintain it for the required duration of 5 years
- Donation of at least €75,000 to the Research and Innovation Foundation. This obligation is lifted, if the applicant has invested at least €75,000 in a certified innovative enterprise
- Donation of at least €75,000 to the Cyprus Land Development Corporation

- Approval of citizenship application in approx. 6 months
- Visa Free Travel to 150+ countries
- Family Package: Citizenship for applicant, spouse, parents and dependants
- No Language Requirements or local history tests
- Allows Dual Citizenship

Helpful Notes

- The Citizenship is granted to the whole family included in the application; applicant, spouse, all financially dependent children (up to the age of 28) and parents of the applicant (provided the parents are the owners of residential property in Cyprus worth at least €500,000)
- The main investment may be sold after 5 years; however, the investor must maintain a property with a value of at least €500,000. Property purchased up to 3 years prior to the submission of the citizenship application will count towards the required investment

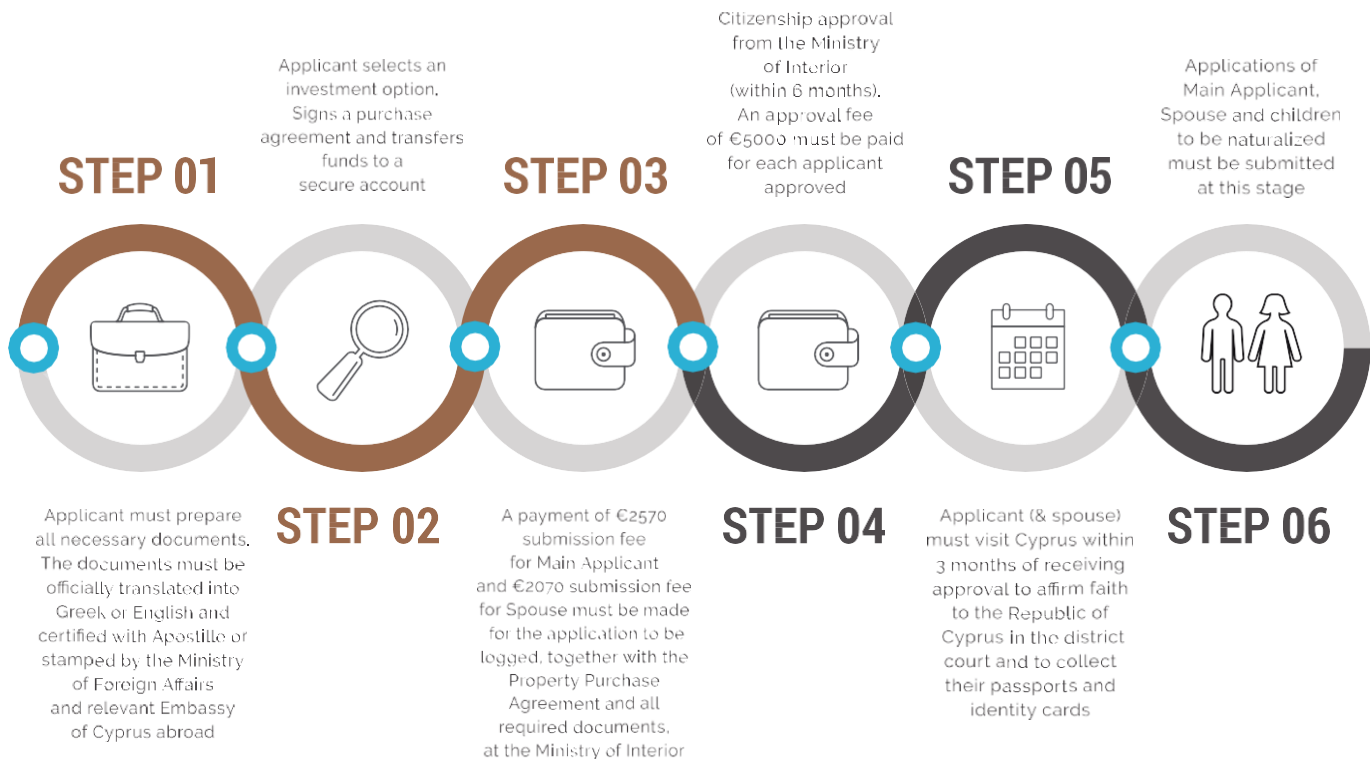
Investment options

A minimum investment of €2 million under one or a combination of the following options, made during the 3 years preceding the date of the application and retained for a period of at least 5 years after the date of the Naturalisation.
